Criteria for Selecting Candidates

To be considered for selection to the Junior Achievement Newfoundland and Labrador Business Hall of Fame, candidates must demonstrate they have fulfilled all three of the following criteria:

1. Candidates must:
 - a. Have demonstrated in his or her business career, an entrepreneurial spirit and have a record of outstanding entrepreneurial achievements over a reasonable period of time;
 - and/or
 - b. Be recognized by his or her organization or profession as having made an outstanding contribution to the success of the organization or profession in support of business excellence;
2. Candidates must have demonstrated effective leadership, not only within his or her organization but in the community;
3. Candidates must be considered a role model for future generations of entrepreneurs and business leaders, as well as others in business.
